Application is hereby made for membership as a Producer Member of the Architectural Precast Association. Applicant hereby agrees to abide by the requirements and conditions of the Articles of Incorporation, Charter, and By-Laws of the Association, and to assist in the attainment of its purposes and objectives by active support and participation in the programs of the Association.

Certification will be issued no earlier than 90 days from the date this application is received. The following must be satisfied before plant certification is approved:

1. All prorated dues must be received by APA
2. Your Quality Control Manual must be approved (format provided).
3. Level I QC Technician, Level II QC Manager, and Batch Plant Operator certification tests must be passed (study guides provided). One person may hold all certifications. There is no charge for the first round of exams and no limit to the number of employees taking them. Multiple certified personnel are encouraged.
4. Plant inspection (preparatory checklist provided).

DUES

Annual producer dues are based on dollar volume of sales of member companies. If a company has multiple plants; then, volume is based on the total sales of all plants. Dollar volume relates to sales F.O.B. plant(s). Dues amounts include two plant certification inspections per year. Please check the category that fits your company the best.

- Producer companies with gross sales less than \$3,000,000 = \$5,900
- Producer companies with gross sales over \$3,000,000 and less than \$8,000,000 = \$6,400
- Producer companies with gross sales over \$8,000,000 = \$7,400

Note: APA Fiscal Year = January 1 to December 31

SPECIAL NOTE: Membership application should be accompanied by a \$1,250 check which covers the cost of your preliminary inspection. **You will receive a separate invoice for membership dues once your certification process is completed.**

After initial year, dues may be paid annually or semi-annually. A \$100 service charge will be assessed for each payment for semi-annual terms. You will be invoiced for prorated dues following successful completion of your preliminary inspection.
